6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 01-06-2026 13:00 at the office of Badigad Rural Municipality, Baglung Badigad-5, Baglung Gwalichaur, Baglung Gandaki Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 45000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[1420115804700041] at [Prabhu Bank Ltd. , badigad, baglung.] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
